

Introduction

England Golf have recently published their Disability Golf Plan as part of the 5-year strategy. Through the plan, our vision is for golf to be one of the leading sports of choice for disabled people in England and to do this we want to ensure golf can be the most inclusive sport regardless of someone's background or ability by investing more focus and resource into growing the offer across England.

Part of the Disability Golf Plan focuses on classification and assessments to support disabled golfers in the process of acquiring an EDGA Player Pass to enable them to participate in future events. The opportunity below will provide this support to disabled golfers by providing them a localised opportunity to get classified ahead of events, to ensure they are best prepared to perform to the highest level.

The Opportunity

England Golf are seeking to recruit 1 or 2 eligibility assessors to review and assess disabled golfers to compete in EDGA (European Disabled Golfers Association) events which will support the disability golf pathway in England. We are working to grow the series of competitions in England and see the role of the eligibility assessor as an integral part of this.

Key Responsibilities

- To be a point of contact for England Golf for any eligibility information coming from the EDGA central eligibility team.
- To support events as required which are EDGA approved across England and other home nations or key stakeholders.
- To assess applications (to an agreed criteria) for golfers wishing to obtain classification.
- To attend and complete the required online course as approved by EDGA

Qualifications

- Qualified Physiotherapist with Chartered status
- Doctor with experience of disability and rehabilitation

Other Requirements

- A valid UK driving licence.
- Preferably, to have a good knowledge of golf.
- To have experience of working with online registration and management systems.
- To be familiar with computer working, including Excel and Word.
- To have their own adequate professional insurance to cover their work.
- DBS vetting check and Safeguarding Training in accordance with England Golf.

Frequency

We anticipate the requirement for the role is 2 to 3 events per year (multiple days) with the potential for this to increase as the infrastructure for competition develops.



Package of Support

- Travel and expenses, in line with England Golf provision.
- Day rate remuneration – approx £250
- England Golf kit provided
- CPD training opportunities
- Plus any additional support as identified

Submission

The tender submission will be assessed against the following criteria:

- Information on the company/individual and the nominated lead contact.
- Experience of supporting disabled people in previous roles and how could you best support our participants.
- Prior experience of work undertaken in sports physiotherapy or rehabilitation and particular disabled people.
- Any prior work in golf or supporting golfers.
- Your availability to work within the timeframe and your estimated cost for this work.

Timeline

This tender document has been issued on 16 September 2025

Tenders are to be submitted at online at www.Englandgolf.org/jobs, using the recruitment link titled Eligibility Assessor. Your tender needs to be submitted as one document, and by no later than 5pm on 14 October 2025.

A selection meeting with those considered will be held week commencing 27 October 2025 and agreements provided, as soon as possible after.
